OUTREACH

In December, MWPS took on numerous cases to support and advocate for the rights of migrant workers in Bahrain.

As always, we distributed essential goods, organised awareness workshops, and worked closely with international organisations.

Highlights include four cases, which involved two Sri

Highlights include four cases, which involved two Sri Lankan nationals, one Kenyan and one Pakistani.

Case 01

A Kenyan national was detained for five months for illegal stay without a valid visa. Her former sponsor, who allegedly abused her during her employment, filed a runaway case against her and was withholding her passport. A new sponsor had expressed willingness to employ her on the condition that she should pay for the visa which she did. In the meantime her daughter passed away in her home country and she wanted to go back. MWPS coordinated with the immigration authorities, and arranged a one-way air ticket. She returned to her home country on December 18, 2024.

Case 02

A Sri Lankan female employee working at a hotel in Bahrain had been working for over a year without receiving her salaries regularly. Despite her visa having expired, she was forced to continue to work without pay. When she demanded her salary, the employer asked for her immediate resignation and refused to pay her dues. MWPS intervened and referred the case to a lawyer. Consequently the employer paid two months' salary to the employee.

Case 03

A Sri Lankan male employee working in a hotel in Bahrain was not receiving his salary regularly. His visa had expired, and he was forced to continue to work. When he asked for his pending salary, the employer asked for his immediate resignation. Although MWPS referred the case to a lawyer the employee returned to Sri Lanka without issuing power of attorney to the lawyer. MWPS is coordinating with him on issuing a power of attorney in Sri Lanka and getting it legalised so that the lawyer would be able to file a case against the hotel once he receives the power of attorney.

Case 04

A Pakistani delivery boy in Bahrain was involved in an accident while working late at night when his motorcycle tyre slipped due to mist. The individual he collided with took him to a private hospital for immediate medical attention. The hospital recommended surgery for a fractured vertebra. He was transferred to Salmaniya Medical Complex (SMC) who confirmed the need for surgery. MWPS paid the charges to carry out the surgery.

BULLETIN

IOM BAHRAIN MARKED INTERNATIONAL MIGRANTS DAY

The International Organisation of Migration (IOM) in Bahrain celebrated International Migrants Day with hundreds from the migrant community on December 20 at the Ramee Grand Hotel, Seef. Partnering with the Labour Market Regulatory Authority on the Working Together initiative, the event honoured migrants' contributions and emphasized their rights. The day featured cultural performances, free health check-ups, and awareness sessions, fostering friendships and a sense of community. The celebration highlighted Bahrain's diverse migrant traditions, with music and dance uniting everyone.









DONATIONS AND DISTRIBUTIONS



MWPS collaborated with the Royal College of Surgeons in Ireland (RCSI) Bahrain on "Movember" awareness activities, engaging students and staff throughout the month. The collaboration culminated in a donation letter handover on December 3, attended by representatives from all RCSI departments. The event, held at the Atrium Reception, included a group photo to commemorate this meaningful partnership.

COMMUNITY GENEROSITY

The Bahrain Netball Team and DHL Express made generous monetary donations to the MWPS. Additionally, several organisations contributed in-kind donations. The Bahrain Netball League, Vitol Bahrain, and Rugby Club Bahrain provided dry rations, while Abdul Rahman Kanoo School, Diyar conducted a blanket drive.









In December 2024, the distribution of essential items to support workers in need was conducted across several locations. On December 7, at Gulf City Cleaning Company's labour camp in Askar, dry ration bags were distributed to 232 workers. On December 13, in Manama, 55 workers from various nationalities, including Haiti, Nigeria, Kenya, India, and the Philippines, who are jobless or low-paid, also received dry ration bags. Additionally, on December 27, 24 workers were provided with blankets. Student interns from various schools participated in the packing and supporting during the distribution.
